

# School Level Planning

- ✓ School level planning involves parents, teachers and administrators on a data team.
- ✓ The Data team analyzes school data (attendance, assessments, benchmarks, discipline and other relevant information) to identify the schools strengths that benefits student achievement and growth and concerns that hinder achievement and growth.

# School Level Planning

- ✓ Using the identified concerns, the data team makes an action plan with specific measures to be carried out by the educators, staff and administration to foster improvement of student achievement and growth.
- ✓ Finally, the plan is adopted for Title I funding and then set into action.
- ✓ Some Goals and Actions Steps overlap in this plan based on School Climate and Data is responsible for implementation and planning..

2. SWIS Systems Training/Procedures and Development for Staff
3. Update and Revise Lesson Plans and Scenarios and Training
4. Update PBIS Reward System and Accountability Frequency
5. Tribe Card Data Collection

# Goal Steps: PBIS and A.T.T.E.N.D.

## **Evidence-based Strategy:**

- ▶ School Climate Committee

## **Action Steps:**

1. Monthly School Climate Meetings
2. Meet with School Climate Focus Groups
3. Administer PA School Climate Survey

## Measurable Goal: TSI Planning

Data team meetings to complete the TSI plan for the following school year. Grade levels will meet monthly to analyze and discuss student progress and areas of weakness in behavior, academics, and attendance. Teachers will be involved in professional learning communities to determine solutions to foster student growth and achievement in all areas.

1. *Monthly Data Team review/revision of current TSI plan*
2. *Monthly Data Team review of current data for next year's TSI plan*
3. *Monthly Grade Level data collection meetings*
4. *Maintain a Full-day Kindergarten program*
5. *ECRI Training for staff*
6. *ECRI implementation K-2*

- ▶ *Social Emotional Learning Program*

## **Action Steps:**

1. *Staff training for 7 Mindsets SEL Curriculum*
2. *Continued Implementation of 7 Mindsets SEL Curriculum*
